Mr Tang is President of Singapore Technologies Electronics Limited's (ST Electronics) Communication & Sensor Systems Group (CSG) with effect from 1 January 2011. He is concurrently President of ST Electronics (Satcom & Sensor Systems) Pte Ltd, after serving as its SVP/General Manager from January 1999 to July 2008. CSG comprises three subsidiaries under the ST Electronics Group – ST Electronics (Info-Comm Systems) Pte Ltd, ST Electronics (Satcom & Sensor Systems) Pte Ltd and STELOP Pte Ltd.

Graduating from Monash University of Australia in 1979 with a Bachelor Degree in Electrical Engineering (Honours, First Class) under a Colombo Plan Scholarship awarded by the Public Service Commission of Singapore, Mr Tang obtained a degree in Master of Science (Industrial Engineering) from the National University of Singapore in 1986 and went on to complete the International Executive Program from INSEAD/France in 2001.

Starting his career as a Project Engineer in Special Projects Organisation in Singapore's Ministry of Defence, he held various management positions from 1982 to 1990 as the organisation expanded and merged with the Material Management Organisation to form the Defence Materiel Organisation. Mr Tang was responsible for the planning and implementation of a number of large-scale strategic sensor and communication systems contributing to the defence capability of Singapore.

Mr Tang joined Singapore Electronics Engineering Limited (SEEL) in 1990, which later became ST Electronics as it expanded. He was instrumental in merging the operations of the major Communication Systems Division of SEEL into ST Electronics (Info-Comm Systems). As the Deputy General Manager of ST Electronics (Info-Comm Systems) then, he was responsible for building up the intellectual property in the company and securing various large contracts that shored the company's foundation for growth.

Mr Tang joined ST Electronics (Satcom & Sensor Systems) in 1999 and has led the company on a healthy growth path, implementing aggressive business expansion strategies, mergers and acquisitions and business excellence initiatives, transforming the company into a global, progressive and innovative sensor and communication systems provider marketing to over 100 countries..

Mr Tang sits on the Board of iDirect Asia Pte Ltd as its Deputy Chairman and is also the Chairman of Datamark Technologies Pte Ltd.
